I apologize for not getting back to you last week.

In the future the landfill activity associated with the Cemetery will be the "A" variety. The fill brought to the site will be levelled and graded for the development of the new section of the cemetery.

The gravel we are going to make on site from the existing stockpiles will be loaded out over the next few months but it is not our intention to make any products on the site after this session.

At present we will be stockpiling concrete and blacktop on the site until we get an alternative site in operation. The District and the City are combining efforts with regard to establishing a spoil recycling site near the waterfront - the hope is this site will be operational early in 2004. Any materials stockpiled at the cemetery in the meantime will be shifted to the new waterfront site for the gravel making process.
